## **Greetings from the Executive Director**

After a rocky 2020 and a struggle to "Achieve Our Vision" during a time that had not been experienced by anyone alive, 2021 was a breath of fresh air. In 2021, The Arc Pikes Peak Region's (The Arc PPR) staff continued to learn to work through the pandemic and to overcome the challenges of providing services in a still somewhat closed world.

2021 brought to life the realization that The Arc PPR could no longer operate as we did in years past. Leadership took a close look at our "sacred cows" (doing things the same way, because they've always been done a certain way) and looked for new ways to serve our participants, whose needs changed during the pandemic.

The impact of COVID-19 on students with intellectual and developmental disabilities (IDD) was enormous and is still felt today. The rapid shift to online learning, increased isolation, and limited access to therapies, placed students with IDD further behind their peers. In 2021, the shortage of paraprofessionals, combined with frustrated parents, increased the number

of families relying on the home school option as their school of choice. Many of these families' frustrations are compounded by additional financial stressors, as one parent is needed to stay home with the homeschooled student. As the adult population looked for ways to be involved in the community, the effects of long-term isolation continued to be a challenge. People with disabilities were uniquely impacted by the pandemic, because they face a greater risk of poor health outcomes, reduced access to routine services and care, and adverse social outcomes. Individuals with disabilities were more likely to face unemployment during and after the pandemic, and those with IDD were six times as likely to die from COVID-19 than other people. And, due to lack of appropriate data collection, and accessibility barriers to receiving information, testing, and vaccination, people with disabilities experienced disparities in the public health response to COVID-19. Therefore, it was important in 2021 that the chapters of The Arc in Colorado remained the strong public policy voice for the IDD community. As we prepared for the challenges that lay ahead, the theme for 2021 was "Don't Stop Believing" -- and The Arc PPR did not.

One major accomplishment in 2021 that I would like to point out, and that I am very proud of, is the operation of COVID-19 Vaccination Clinics. In partnership with the Colorado Public Health & Education department, The Arc PPR took the lead in offering vaccination clinics. On Monday, February 22, 2021, The Arc PPR hosted the first of many vaccination clinics targeting the disabled population and health care workers. More than 500 individuals received their first and second vaccinations at The Arc PPR, while more than 90 percent of the participants were from the disability community.

The Arc PPR did not stop there. On June 12, 2021, The Arc PPR was the first disability organization or Colorado chapter of The Arc to resume outdoor programming with our "Chillin' with the Cool C.A.T.S. (Children of All Types Succeeding)" summer events. More than 150 families joined The Arc PPR and our other community partners in the fun. These are just a few of the many ways The Arc PPR made a difference in 2021. I am proud to be the executive director of this fine organization that puts our families and the individuals we serve first, and I was ready to "Ride the Wave" into 2022.








#### ADVOCACY

The Advocacy Program safeguards the rights of individuals with intellectual and developmental disabilities, facilitates choices, and promotes independence and inclusion in community life. Advocacy takes place at both the individual and systemic levels. The Arc's highly qualified advocates attend school IEP meetings, residential and/or day program staffings, and provide resources in times of crisis. Adult advocacy includes gathering information about local programs and monitoring them to ensure services meet identified needs and are consistent with laws, regulations, and standards of quality. System advocacy monitors public policy and legislation at local, state, and federal levels.

#### GUARDIANSHIP

The Arc Pikes Peak Region serves as the legal guardian to adults with an intellectual and/or developmental disability, with a growing waiting list. When the Probate Court appoints The Arc as legal guardian, staff members are named as agents to provide the guardianship services. Guardianship services include evaluation of the individual's needs and services, attendance at all staffings and individual plan meetings, at least one monthly visit, 24-hour emergency on-call services, consent for medical treatment, and annual report to the probate courts. For people who are not capable of making informed decisions, the Guardianship Program offers both protection and enhancement of individual rights.



#### EDUCATION

Additionally, The Arc Pikes Peak Region provides workshops, speakers, educational materials, and a lending library on a wide range of issues that concern people with intellectual and developmental disabilities and their friends and families. With the opening of the Building for Change Inclusive Personal Development Center and the Disability Resources Library (pictured below), the community will also have access to helpful resources on a wide variety of disability-related topics.





#### **SOCIAL EVENTS**

The Arc PPR hosts a variety of social events for individuals of all abilities. These accessible events occur throughout the year and include The Arc Ball, Halloween Dance, Sweetheart's Dance, Cool C.A.T.S (Children of All Types Succeeding) Club events, Sisterhood of Empowered Women, Guys' Night Out, and others.

#### arc THRIFT CONNECTION

All 15 chapters of The Arc in Colorado are funded by arc Thrift Stores. The thrift stores were created in 1963 as a way to support the work done by the chapters. Over the years, the thrift stores have grown to be wildly successful. Their sales continue to support The Arc chapters and programs, supporting individuals with intellectual and developmental disabilities. This special relationship between arc Thrift and The Arc PPR allows us to advocate for the rights and responsibilities of individuals with intellectual and developmental disabilities.



# Year-in-Review



#### Indy Give! Campaign

In 2021, The Arc Pikes Peak Region participated in Indy Give!, a year-end giving campaign. Together with an S11,750 matching grant from: arc Thrift Stores, Blake and Kathleen Wilson, IT Specialists, John P. Nelson Associates, Rocky Mountain Insurance Advisors, Colorado Fun Guide, The Arc PPR Pooled Income Trust, Cascade Investment Group, Erickson, Brown & Kloster, Michelle Enciso, and Yolanda Garcia Insurance Agency, The Arc PPR raised S18,774.94. This success was a result of fundraising efforts from the entire staff, the Board of Directors, and the friends of The Arc Pikes Peak Region.



#### 2021 Events

After a long hiatus from in-person events due to COVID-19, The Arc PPR teamed up with the Cool C.A.T.S (Children of All Types Succeeding) adaptive cycling team for the Chillin' with the Cool C.A.T.S outdoor summer events series. Throughout the summer, community partners and other disability organizations gathered to sponsor fun activities, a picnic lunch, and adaptive cycling rides for participants.

Events that continued virtually included: the Achieve with Us Colorado Film Festival, Annual Awards Celebration, "Our Music, Our Voice," led by multi-instrumentalist Jorden Smith, The Arc Ball, Halloween Dance, Karaoke Parties, and Sisterhood of Empowered Women.



#### Include U.S.A

Include USA is a self-advocacy group sponsored by The Arc PPR and advised by advocacy specialists Connor Cassidy and Connie McKenzie. Throughout 2021, the group continued to meet virtually, while maintaining an active participation in Speaking for Ourselves Colorado (SFO CO). SFO CO is a statewide, grassroots organization of people with disabilities who want to speak for themselves on issues that involve and effect them. Chapters across Colorado meet by conference call once per month, and they also meet quarterly in various places around the state. The group learns about their rights and how to advocate for themselves so that their rights are not overlooked. Include USA has fundraised, worked on transportation issues, and volunteered around the community.




