

Organized in 1955 by a group of parents of people with intellectual and developmental disabilities, The Arc Pikes Peak Region is a local chapter of a national organization of parents, professionals, and interested citizens. Together, more than 700 state and local chapters of The Arc form the largest volunteer organization in the U.S. These chapters are devoted solely to the welfare of the more than seven million people with intellectual and developmental disabilities and their families.

Greetings from the Executive Director



Wilfred Romero Executive Director 2020 began with the theme "Achieve Your Vision for 2020." Little did we know we were seeing with blurry vision when deciding on our theme choice. Much of the country was still recuperating from the holidays when our world turned upside down due to COVID. Even considering what was to come, I was excited with how we opened 2020. Board of Directors member, Mitch Routon, and I were in Washington, D.C. for The Arc of the United States (The Arc US) board of Directors meeting. Following his freshman year on the board, it was exciting to watch Mitch take on new board member leadership responsibilities. We discussed the Disability Policy Agenda, as well as the impact The Arc Pikes Peak Region (The Arc PPR) would have in public policy. While in D.C., we became aware of the new health threat impacting China, and soon after, the world.

Executive Director We came home optimistic about the future, and we began planning for another trip to Washington D.C. in April 2020, alongside other board members who were anxious to make their voice heard. Just as fast as we made travel plans, the course of the world came to an abrupt halt in March 2020. The Arc PPR leadership had to make a quick paradigm shift from the 'Achieve Your Vision for 2020" theme, to adapting to the everchanging needs of the disability community brought on by COVID-19. Much of the dilemma focused on ensuring the disability community was included in the government's efforts to address the pandemic.

I am proud to report that while the rest of the world was scrambling to put together an action plan, The Arc PPR Board of Directors was ahead of the game. In December 2019, the board had a discussion of the need to have a Risk Management Plan developed in preparation of opening of the Building for Change Inclusive Personal Development Center campus. Our main objective was to be proactive in eliminating risk, rather than being reactive. With that goal in mind, a Risk Management Committee was established, and a Risk Management Plan was already in draft form when the pandemic hit. I commend The Arc PPR 2020-2021 board of directors for forward thinking in protecting the organization and the individuals we serve.


As COVID-19 took over 2020, I am proud of the staff and their ability to shift gears on how we conducted business. The staff was quick to develop programs and social opportunities via zoom and other social media outlets, while keeping The Arc PPR mission and the ever-changing needs of the disability community in mind. On the national level, The Arc PPR, along with other Colorado chapters of The Arc, were active in ensuring that individuals with intellectual and developmental disabilities were included in the conversation when dealing with the pandemic. These conversation topics included isolation in hospital settings, access to vaccines, access to financial assistance, and criminal justice reform.

As we entered 2021, we did not stop believing that we would or could find the silver lining in all the world's craziness -- and we did! The Arc PPR is proud to report that the "Building for Change" campaign continued to move forward in 2020, and we will soon celebrate the grand opening of The Arc PPR Inclusive Campus -- a campus where people of all abilities are welcomed!

What We Do

Advocacy

The Advocacy Program safeguards the rights of individuals with intellectual and developmental disabilities, facilitates choices, and promotes independence and inclusion in community life. Advocacy takes place at both the individual and systemic levels. The Arc's highly qualified advocates attend school IEP meetings, residential and/or day program staffings, and provide resources in times of crisis. Adult advocacy includes gathering information about local programs and monitoring them to ensure services meet identified needs and are consistent with laws, regulations, and standards of quality. System advocacy monitors public policy and legislation at local, state, and federal levels.







Guardianship

The Arc Pikes Peak Region serves as the legal guardian to adults with an intellectual and/or developmental disability, with a growing waiting list. When the Probate Court appoints The Arc as legal guardian, staff members are named as agents to provide the guardianship services. Guardianship services include evaluation of the individual's needs and services, attendance at all staffings and individual plan meetings, at least one monthly visit, 24-hour emergency on-call services, consent for medical treatment, and annual report to the probate courts. For people who are not capable of making informed decisions, the Guardianship Program offers both protection and enhancement of individual rights.

are thrift Connection





Events in LOLO - Pivoting to Virtual

Just weeks after a successful "Achieve Your Vision" Art Gallery, in collaboration with Local Relic Brewery (pictured at left), as well as an in-person Sweetheart's dance, with nearly 400 people in attendance, the world abruptly shifted in response to the COVID-19 crisis. The Arc Pikes Peak Region's staff quickly pivoted many of our events to a virtual format to best serve our program participants. Events like Move-it-Monday incorporated a wide variety of virtual fitness activities to keep people moving and healthy, while our popular Virtual Karaoke Party drew regular Zoom crowds to cheer each other on as we sang our favorite tunes. Our Online Parent

Support Group provided an outlet for parents to help one another cope with the stressors of simultaneously working from home while navigating the challenges of virtual learning. Program participants also enjoyed a virtual music class for all abilities, "Our Music, Our Voice," led by The Arc PPR's staff member and multi-instrumentalist, Jorden Smith. Additionally, we hosted our popular Arc Ball, as well as our Annual Awards celebration, virtually.




include USA is a self-advocacy group sponsored by








